

Stella's Place Website Terms of Use

1. Agreement to Terms

This website Terms of Use is a binding legal agreement between you and Stella's Place governing your access to and use of the Stella's Place website located at www.stellasplace.ca and all electronic media channels or platforms that Stella's Place may operate or make available, including external websites used to promote or provide Stella's Place services (e.g., event planning or ticketing websites) and Stella's Place specific pages on social media sites (e.g., Facebook, Twitter, Instagram). All such channels, platforms, social media pages, and service affiliations are referred to in this policy collectively as the "Website".

5. Agreement to Changes or Updates

6. Restrictions on Use of Content

You may use the Website only in the manner provided for in these Terms of Use (for your personal use). To be clear, you are permitted to access and use the Website and make a copy of Content on the Website for your personal and non-commercial use.
